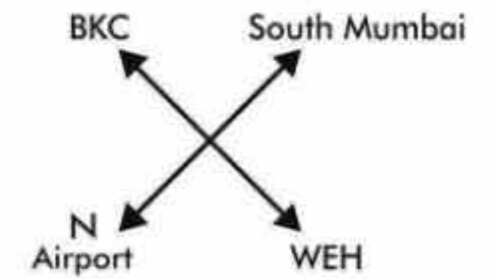

PENTHOUSE: LOWER FLOOR PLAN

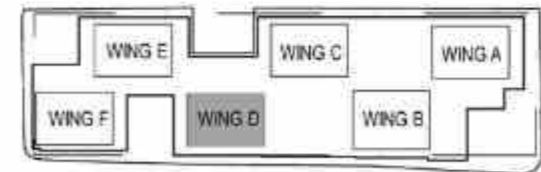

PENTHOUSE: UPPER FLOOR PLAN

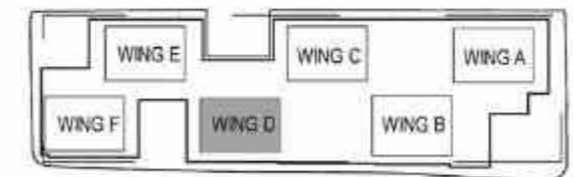
